## Tikanga Ora Reo Ora (TORO) GRANT

The TORO Grant aims to equip and empower tribal members to fulfil their role as Kaitiaki of Te Reo Maaori me ngaa Tikanga. The grant is awarded to projects that align to the Tikanga Ora Reo Ora (TORO) and its objectives. The grant aims to; enable tribal members and marae to build capacity in Te Reo Maaori, Tikanga Maaori and Maatauranga Maaori through strategic planning, developing and implementing their reo and tikanga aspirations; and empower tribal practitioners to lead projects and initiatives that meet marae and tribal aspirations. Applications must outline;

- Applicant’s experience/knowledge in implementing reo and tikanga projects and/or initiatives. This can be outlined in a CV or Profile.
- Support of marae for the project/initiative to take place. This can be evidenced as an endorsement letter or email from a Marae Executive (at least one marae endorsement required)
- Alignment to the Tikanga Ora Reo Ora (TORO) Strategy.
- Evidence of charitable status where an applicant is a trust or organisation.
- Confirmation that the applicant and at least 50% of the persons benefiting from the grant are registered Waikato-Tainui tribal members. A list of full names, dates of birth and registration numbers must be supplied.
- Full details of the project including expected outcomes, dates, venues, proposed benefits and budget.

Other details are as follows;

- Upon acceptance, applicants will be required to complete a report showing the outcomes received from the funding including statistics, measures indicating improvement and testimonials.
- Conditions for each awarded grant may differ depending on the nature of the project or initiative.
- Only one funding application will be considered per marae/trust/organisation/individual within each financial year.
- Grant applications will be considered monthly.
- Sole discretion to accept or decline a grant that does not meet criteria rests with us. Decisions are final and no correspondence will be entered into.
- Grants will be paid into a marae/trust/organisations bank account, not an individual’s account.

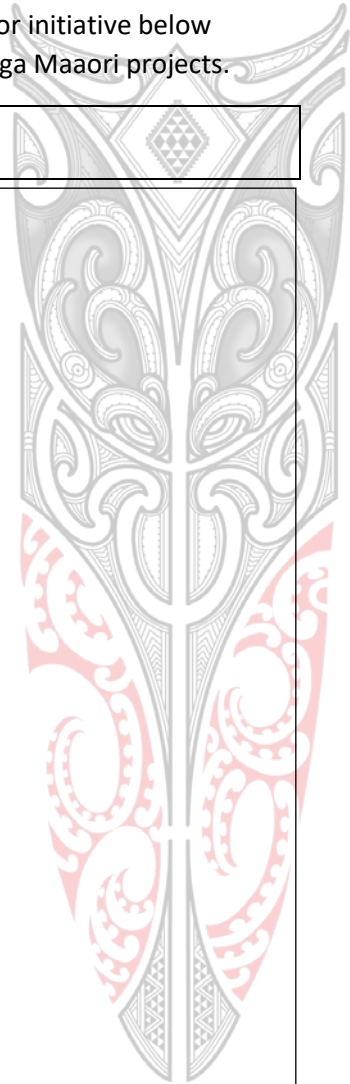

## TORO GRANT CRITERIA

### ALIGNMENT:

All funding allocations from the TORO Grant putea must be aligned to the Tikanga Ora Reo Ora (TORO) Strategy, specifically to Ngaa Pou as outlined below.

### ASSESSMENT

All applications will be assessed by the TORO Advisory Board before being recommended for approval. The TORO Advisory Board will assess applications based on alignment to the organisations strategic priorities which are:

- 1) To empower our Marae to achieve their aspirations
- 2) To enable our tribal members to fulfil their potential

As well as our vision for Tikanga Ora Reo Ora (TORO) which is:

- 3) Our Marae and tribal members are supported and empowered to fulfil their role as kaitiaki te reo me ngaa tikanga

### OBJECTIVES

Through the TORO Grant, we will:

- Assist tribal members to build their capacity to practice their own reo, tikanga and Maatauranga Maaori
- Assist marae to plan, develop and implement their cultural aspirations for their Marae and marae members
- Enable our tribal reo, tikanga and Maatauranga Maaori practitioners to lead and participate in tribal, marae and other cultural projects and initiatives

### PROCESS

The application process will be guided by the Distribution & Grants Policy, whereby we will accept written applications via an application form. The application will be assessed by the TORO Advisory Board and a recommendation will be provided to the Distributions Committee for approval by Te Arataura.

### GRANT PRIORITY AREAS

The following table lists the proposed areas that the TORO Grant may fund;

<p><b>1. Ngaa Waituhi</b></p> <p>‘Kia rangahaua ngaa tohu o te mana o te reo me ngaa tikanga hei aarahi i te anga whakamuatanga.’</p> <p>Grants to assist and enable robust research to be undertaken on kaupapa to inform strategic direction. Examples include; researching the state of te reo among marae, Kaahui marae and/or hapuu; consultation; data collation to develop strategic planning; language revitalisation</p>

techniques and methods; innovation in the advancement of te reo, tikanga and/or Maatauranga Maaori specific to your marae, hapuu and/or iwi.

## **2. Ngaa Tiwha**

‘Kia whakatairangatia te kitenge, te paanuitanga, te rongotanga, te koorerotanga o te reo me ngaa tikanga i ngaa waahi katoa e whai paanga ai a Waikato-Tainui.’

Waikato-Tainui recognises the need to support Marae/Hapu to promote reo and tikanga through multiple mediums of communication to increase the use of te reo, tikanga and Maatauranga Maaori in their daily activities and settings. Examples include; marae signage, marae online profiles, webinars, reo promotion, etc.

## **3. Ngaa Tukutuku**

‘Kia whakakotahingia ngaa maramara maatauranga o Waikato-Tainui hei taonga tuku iho.

Waikato-Tainui recognises that marae, hapuu and whanau collectives hold unqie and substantial knowledge of their own reo, tikanga and Maatauranga Maaori. This fund will support these collectives to provide knowledge transfer initiatives to ensure this unique knowledge and language is sustained.

Examples include; mana whenua storytelling, kaumaatua interviews, transcribing, short films, etc.

## **4. Ngaa Whakairo**

‘Kia whakairohia te reo me ngaa tikanga ki te ngaakau o te iwi.’

Waikato-Tainui recognises that reo and tikanga etched into the hearts of the people will ensure the life of the reo and tikanga for generations to come. This fund will support opportunities for tribal members to engage in waananga reo, tikanga and/or Maatauranga Maaori.

## **5. Ngaa Takarangi**

‘Kia arotake, kia aromatawai, kia arohaehae i ngaa hua o te rautaki.’

The fund will support opportunities for tribal members to evaluate, assess and critically appraise outcomes of reo and tikanga strategies implemented.
